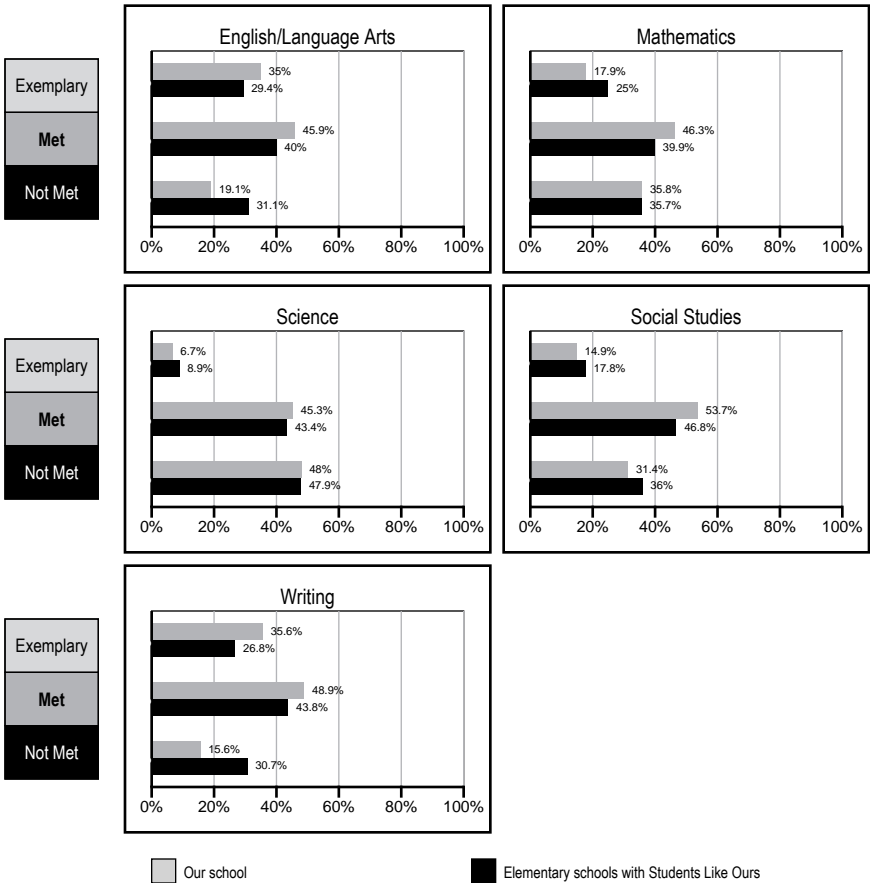

Report of Principal and School Improvement Council

The 2010-11 school year saw the Sheridan Superstar administration, faculty, staff, students, and parents shine as they worked together to accomplish the goal of improved academic success for our students. At Sheridan Elementary, it is our mission to provide a safe, nurturing, and stimulating environment, enabling our students to become productive citizens while ensuring that all students feel special and that no child is left behind.

Our curriculum and academic instruction was based upon the South Carolina Academic Standards for each grade level and subject. This year, through the use of diagnostic tools such as Dominic, Dibels, MAPPS, and district benchmarks, our curriculum was data driven. Results of assessments were used to target skills and standards in which students were weak and additional instruction was then provided.

At Sheridan Elementary, we believe in the development of well-rounded students. To achieve this, a variety of programs, clubs, and after-school activities were offered to enhance the academic, social, emotional, and physical growth of our students. These included character education, Century 21, after-school tutoring, Saturday Academy, science fair, Garden Club, Book Club, quarterly awards program, Good News Club, Grandparents' Luncheon, career week, field trips, yearbook, Girls' Circle, Pizza Math, Accelerated Reader, Mr. and Miss Sheridan Pageant, WSES morning news program, and the drill team.

Our arts department had a very productive year. Sheridan offered our students opportunities for instruction and performance in chorus, strings, recorders, hand bells, and steel pan drums. The chorus, strings, and recorder performers all excelled at district competitions. A highlight of the school year was having our chorus, strings, and hand bells perform at WIS-TV at Christmas. Our Sheridan Elementary Arts Festival highlighted our students' musical and artistic talents. Sheridan was also fortunate to have a group of volunteer college students from Ohio do artwork around our campus.

This year, the faculty and staff participated in a variety of professional growth activities to include workshops on Failure Is Not An Option, Voyager, and Passport. Nine faculty members received \$500 grants to assist our students in academic improvement, and the school also received a \$5,000 grant from Dollar General which was used for literacy. The Sheridan PTSA and school improvement council continue to work hard to support our school's mission and our students by providing activities and monetary support for programs during the school year.
