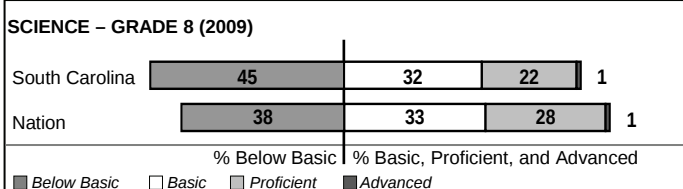
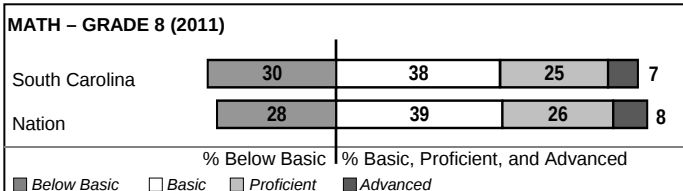
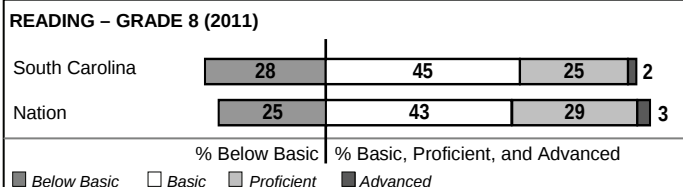
PASS PERFORMANCE
