Serving the three high schools in Sumter County, Sumter Career and Technology Center continues to enjoy a positive relationship with its business and industrial partners. We continue to develop positive relationships with our stakeholders in the community. We participated in the school district community outreach program of Principal For a Day, in which a key community member came into the school to see what the day in the life of a principal is like. The principal remains actively involved with the Industrial Association. We received additional grant funding for our Green House Project, and the construction of the state-of-the-art building is complete. We continue to place emphasis on instructional rigor, and we have worked diligently with the guidance counselors to insure that enrollment of students at the Career Center meet specific prerequisites for enrollment. Our faculty and staff participated in our district wide focus of effective teaching practice, through professional development, while also analyzing our student data by developing our building data teams.☐

We continue to bring the guest speakers from the community to the campus to address our students, and they are encouraged to participate in a number of community development activities such as nursing home visits, fundraisers for the American Cancer Society and the American Heart Association. Our fire and safety management and welding classes participated in Skills USA event in Greenville. Fire and safety management placed first in the state for first aid/CPR and will be competing at nationals in Kansas this summer. Students from our welding class placed second and third in the welding singles and team fabrication competitions. We also have several students in FCCLA, from our Culinary Arts and Early Childhood Education, who placed in the FCCLA competition and they will be competing in the nationals in Texas this summer.☐

Our partnership with Central Carolina Technical College (CCTC) remains strong. We had several students from our early childhood education class dually enrolled, and they received post-secondary credit during the school year. We are excited that more students have passed their entrance test for CCTC and will also enroll this summer and fall.☐

This waiver allowed SC to replace the former pass/fail system with one that utilizes more of the statewide assessments already in place and combine these subject area results with graduation rate (in high schools) to determine if each school met the target or made progress toward the target. This analysis results in a letter grade for the school rather than the pass/fail system of previous years.
