SUMMARY OF THE CASE

Brent Blackwell was employed as a teacher at J.L. Mann High School (hereinafter "School") in Greenville County School District (hereinafter "District") during the 2011-2012 school year. During this period, the District became aware that Mr. Blackwell had violated school policy by failing to report an arrest to his employer. Mr. Blackwell resigned from his position with the District in lieu of termination.

Mr. Blackwell does not wish to return to teaching, and therefore waives his right to a hearing and enters into this Consent Order of Voluntary Surrender.

After considering the evidence presented, the State Board voted to accept this Consent Order of Voluntary Surrender, effective on August 13, 2014. The surrender of Mr. Blackwell's educator certificate shall be reported to all school districts in South Carolina and the NASDTEC Clearinghouse within thirty days of this order with the reasons stated as "unprofessional conduct."

CONCLUSIONS OF LAW

The State Board, upon careful review of the evidence presented, makes the following conclusions of law in this matter:

- (1) The State Board has jurisdiction in this matter pursuant to S.C. Code Ann. § 59-25-150 (2004), which provides "The South Carolina Board of Education may, for just cause, revoke or suspend the certificate of any person."
- (2) Just cause is statutorily defined to include "Unprofessional conduct." S.C. Code Ann. § 59-25-160(4) (2004).
- (3) The evidence demonstrates that Mr. Blackwell committed unprofessional conduct by violating clear District policies regarding self-reporting arrests.
- (4) The evidence presented supports the State Board's decision to accept the voluntary surrender of the educator certificate of Brent Blackwell, certificate 236068, effective August 13, 2014.

NOW THEREFORE, it is ordered that the State Board accepts the Consent Order and the educator certificate of Brent Blackwell, certificate 236068, is hereby surrendered. This action on certificate 236068 shall be reported to the NASDTEC Clearinghouse and all South Carolina school districts within thirty days from the date of this order with the reasons stated as "unprofessional conduct."
