**ORDER OF SUSPENSION
(BREACH OF CONTRACT)**

SUMMARY OF THE CASE

The South Carolina State Board of Education (State Board) considered this matter on February 8, 2022. On January 5, 2022, the South Carolina Department of Education (SCDE) sent Sarah Margaret Keistler a notice via regular and certified mail, return receipt requested, of her right to a hearing regarding the possible suspension of her South Carolina educator certificate. Ms. Keistler received the notice on January 7, 2022, as evidenced by signed postal receipt. She has not contacted the SCDE to request a hearing and is now in default.

Considering the evidence presented, the State Board voted to suspend Ms. Keistler's educator certificate for a period of one year, commencing February 8, 2022, and ending on February 7, 2023.

FINDINGS OF FACT

This case concerns a formal complaint of Aiken County Public School District (District) seeking the suspension of the educator certificate of Ms. Keistler for breach of contract. The State Board has jurisdiction in this matter pursuant to S.C. Code Ann. § 59-25-150 (2018) and S.C. Code Ann. § 59-25-530 (2018).

On July 23, 2021, Ms. Keistler signed a contractual agreement with the District to serve as a 1.0 Teacher for North Augusta High School [2021-22]. On November 2, 2021, Ms. Keistler submitted her resignation to the District, effective November 5, 2021. Ms. Keistler informed the District she'd been offered a position with a textbook company. Ms. Keistler was notified she would not be released from her contract until a suitable replacement was found. She did not return to fulfill her contract after November 5, 2021. The District Board voted to report Ms. Keistler's breach of contract to the SCDE on December 14, 2021. On December 16, 2021, the District reported the matter to the SCDE.

After considering the evidence, the State Board finds that the evidence presented demonstrates that Ms. Keistler breached her contract with the District, and that just cause exists to suspend Ms. Keistler, certificate 286119, for a period of one year, commencing on February 8, 2022, and ending on February 7, 2023.

CONCLUSIONS OF LAW

“The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person.” Just cause includes, inter alia, “unprofessional conduct” and “willful violation of the rules and regulations of the State Board of Education.” S.C. Code Ann. § 59-25-160 (3) and (4) (2018). Pursuant to 24 S.C. Code Regs. 43-58 (2) and (14) (2018), the State Board of Education had the legal authority to suspend a certificate for “failure to comply with the provision of a contract without the written consent of the local school board.” With respect to breach of contract, “any teacher who fails to comply with the provisions of his [or her] contract without written consent of the school board shall be deemed guilty of unprofessional conduct.” S. C. Code Ann. § 59-25-530 (2018). “Upon formal complaint of the school board, substantiated by conclusive evidence, the state board shall suspend or revoke the teacher’s certificate, for a period not to exceed one calendar year.” *Id.*

The State Board finds that the evidence presented demonstrates that Ms. Keistler breached her contract without the consent and/or approval of the District. Accordingly, the evidence presented supports the State Board’s determination that just cause exists to suspend the educator certificate of Sarah Margaret Keistler for a period of one year, commencing on February 8, 2022, and ending on February 7, 2023.

If Ms. Keistler wishes to have her educator certificate reinstated at the end of the suspension period, she shall make a written request to the SCDE’s Office of Educator Services and shall meet all certification requirements in effect at the time she requests reinstatement. Ms. Keistler shall also pay the applicable reinstatement fee. The suspension of Ms. Keistler’s educator certificate 286119 shall be reported to the NASDTEC Clearinghouse and all South Carolina school districts within thirty days from the date of this order, with the reason stated as

“unprofessional conduct, breach of contract, willful neglect of duty, and failure to comply with the provisions of a contract without the written consent of the local school board.”
