**CHURILLO ANGELA
CONSENT ORDER OF SUSPENSION
(BREACH OF CONTRACT)**

SUMMARY OF THE CASE

The South Carolina State Board of Education (State Board) considered this matter on April 11, 2023. On February 7, 2023, the South Carolina Department of Education (SCDE) sent Angela Churillo a notice via regular and certified mail of her right to a hearing regarding the possible suspension of her South Carolina educator certificate based on her breach of contract. Ms. Churillo contacted the SCDE to discuss an alternate resolution in lieu of a hearing. Ms. Churillo has agreed to waive her right to a hearing and enter into this Consent Order of Suspension.

After considering the evidence presented, the State Board voted to suspend Ms. Churillo's educator certificate for a period of one year, commencing April 11, 2023, and ending April 10, 2024.

FINDINGS OF FACT

This case concerns a formal complaint from the Greenville County School District (District) seeking the suspension of the educator certificate of Ms. Churillo for breach of contract. The State Board has jurisdiction in this matter pursuant to S.C. Code Ann. § 59-25-150 (2020) and S.C. Code Ann. § 59-25-530 (2020).

On April 1, 2022, Ms. Churillo signed a contractual agreement with District to serve as a teacher for the 2022-23 school year. Ms. Churillo submitted her resignation on November 21, 2022, effective December 16, 2022. In a statement to the SCDE, Ms. Churillo maintained she resigned from her employment because she found it impossible to teach in the behavioral climate of the school. Ms. Churillo believed the conditions constituted "extenuating circumstances" justifying her release from her contract. Despite

these contentions, Ms. Churillo has chosen to enter into this Consent Order of Suspension rather than pursuing a hearing in the matter. Ms. Churillo informed the District and gave three weeks' notice of her resignation. The District informed Ms. Churillo that she would be released from her contract once a suitable replacement was found via letter on November 28, 2022. On January 24, 2023, the School Board of Trustees voted to report Ms. Churillo's breach of contract to the SCDE. On February 3, 2023, the District reported the matter to the SCDE.

After being notified of the pending action against her educator certificate, Ms. Churillo contacted the SCDE to discuss an alternative resolution to a hearing. Ms. Churillo has agreed to the suspension of her educator certificate for a period of one year, beginning April 11, 2023, and ending April 10, 2024.

After considering the evidence, the State Board finds that the evidence presented demonstrates that Ms. Churillo breached her contract with the District, and that just cause exists to suspend Ms. Churillo's certificate 309450 for a period of one year, commencing on April 11, 2023, and ending April 10, 2024.

CONCLUSIONS OF LAW

"The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person." Just cause includes, inter alia, "unprofessional conduct" and "willful violation of the rules and regulations of the State Board of Education." S.C. Code Ann. § 59-25-160 (3) and (4) (2020). Pursuant to 24 S.C. Code Regs. 43-58 (2) and (14) (2021), the State Board of Education has the legal authority to suspend a certificate for "failure to comply with the provision of a contract without the written consent of the local school board." With respect to breach of contract, "any teacher who fails to comply with the provisions of his [or her] contract without written consent of the school board shall be deemed guilty of unprofessional conduct." S. C. Code Ann. § 59-25-530 (2020). "Upon formal complaint of the school board, substantiated by conclusive

evidence, the State Board shall suspend or revoke the teacher's certificate, for a period not to exceed one calendar year."

The State Board finds that the evidence presented demonstrates that Ms. Churillo breached her contract without the consent and/or approval of the District. Accordingly, the evidence presented supports the State Board's determination that just cause exists to suspend the educator certificate of Angela Churillo for a period of one year, commencing on April 11, 2023, and ending on April 10, 2024. If Ms. Churillo wishes to have her educator certificate reinstated at the end of the suspension period, she shall make a written request to the SCDE's Office of Educator Services and shall meet all certification requirements in effect at the time she requests reinstatement. Ms. Churillo shall also pay the applicable reinstatement fee. The suspension of Ms. Churillo's educator certificate 309450 shall be reported to the NASDTEC Clearinghouse and all South Carolina school districts within thirty days from the date of this order, with the reason stated as "unprofessional conduct, breach of contract, willful neglect of duty, and failure to comply with the provisions of a contract without the written consent of the local school board."

AND IT IS SO ORDERED.
