**CONSENT ORDER OF SUSPENSION
(BREACH OF CONTRACT)**

SUMMARY OF THE CASE

The South Carolina State Board of Education (State Board) considered this matter on June 13, 2023. On March 8, 2022, the South Carolina Department of Education (SCDE) sent Allison B. Lazor a notice via regular and certified mail of her right to a hearing regarding the possible suspension of her South Carolina educator certificate based on her breach of contract. Ms. Lazor timely requested a hearing in the matter. Prior to the hearing, Ms. Lazor contacted the SCDE to discuss an alternate resolution. Ms. Lazor has agreed to waive her right to a hearing and enter into this Consent Order of Suspension.

After considering the evidence presented, the State Board voted to suspend Ms. Lazor's educator certificate for a period of forty-five days, commencing May 9, 2023, and ending June 23, 2023.

FINDINGS OF FACT

This case concerns a formal complaint from the Lexington County School District Two seeking the suspension of the educator certificate of Ms. Lazor for breach of contract. The State Board has jurisdiction in this matter pursuant to S.C. Code Ann. § 59-25-150 (2020) and S.C. Code Ann. § 59-25-530 (2020).

On April 15, 2021, Ms. Lazor signed a contractual agreement with Lexington County School District Two to serve as an educator for the 2021-22 school year. Ms. Lazor submitted her resignation on November 11, 2021, effective December 17, 2021, citing personal reasons. The Lexington County School District Two informed Ms. Lazor that her breach had been reported to the Board of Trustees on November 19, 2021. On November 18, 2021, the School Board of Trustees voted to report Ms. Lazor's breach of contract to the SCDE. On March 4, 2022, the District reported the matter to the SCDE.

After being notified of the pending action against her educator certificate, Ms. Lazor contacted the SCDE to discuss an alternate resolution. Ms. Lazor has agreed to the suspension of her educator certificate for a period of forty-five days, beginning May 9, 2023, and ending June 23, 2023.

After considering the evidence, the State Board finds that the evidence presented demonstrates that Ms. Lazor breached her contract with the District, and that just cause exists to suspend Ms. Lazor's certificate 269417 for a period of forty-five days, commencing on May 9, 2023, and ending June 23, 2023.

CONCLUSIONS OF LAW

"The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person." Just cause includes, inter alia, "unprofessional conduct" and "willful violation of the rules and regulations of the State Board of Education." S.C. Code Ann. § 59-25-160 (3) and (4) (2020). Pursuant to 24 S.C. Code Regs. 43-58 (2) and (14) (2021), the State Board of Education has the legal authority to suspend a certificate for "failure to comply with the provision of a contract without the written consent of the local school board." With respect to breach of contract, "any teacher who fails to comply with the provisions of his [or her] contract without written consent of the school board shall be deemed guilty of unprofessional conduct." S. C. Code Ann. § 59-25-530 (2020). "Upon formal complaint of the school board, substantiated by conclusive evidence, the State Board shall suspend or revoke the teacher's certificate, for a period not to exceed one calendar year."

The State Board finds that the evidence presented demonstrates that Ms. Lazor breached her contract without the consent and/or approval of the Lexington County School District Two. Accordingly, the evidence presented supports the State Board's determination that just cause exists to suspend the educator certificate of Allison B. Lazor for a period of forty-five days, commencing on May 9, 2023, and ending on June 23, 2023.

If Ms. Lazor wishes to have her educator certificate reinstated at the end of the suspension period, she shall make a written request to the SCDE's Office of Educator Services and shall meet all certification requirements in effect at the time she requests reinstatement. Ms. Lazor shall also pay the applicable reinstatement fee. The suspension of Ms. Lazor's educator certificate 269417 shall be reported to the NASDTEC Clearinghouse and all South Carolina school districts within thirty days from the date of this order, with the reason stated as "unprofessional conduct, breach of contract, willful neglect of duty, and failure to comply with the provisions of a contract without the written consent of the local school board."

AND IT IS SO ORDERED.
