**ORDER OF SUSPENSION
(BREACH OF CONTRACT)**

SUMMARY OF THE CASE

The South Carolina State Board of Education (State Board) considered this matter on March 14, 2023. On October 27, 2022, the South Carolina Department of Education (SCDE) sent Kelly Marie Bunts a notice via regular and certified mail of her right to a hearing regarding the possible suspension of her South Carolina educator certificate. The SCDE has verified Ms. Bunts' address and the letter sent via regular mail has not been returned. On November 17, 2022, the SCDE informed Ms. Bunts via regular mail that the State Board would meet on January 13, 2023, or as soon thereafter as is feasible, to consider action against her educator certification. Under the South Carolina Rules of Civil Procedure 5(b), Ms. Bunts has been given fair notice of constitutional due process. Ms. Bunts has not contacted the SCDE to request a hearing and is now in default.

After considering the evidence presented, the State Board voted to suspend Ms. Bunts' educator certificate for a period of one year, commencing March 14, 2023, and ending on March 13, 2024.

FINDINGS OF FACT

This case concerns a formal complaint of the Chester County School District (District) seeking the suspension of the educator certificate of Ms. Bunts for breach of contract. The State Board has jurisdiction in this matter pursuant to S.C. Code Ann. § 59-25-150 (2020) and S.C. Code Ann. § 59-25-530 (2020).

On May 3, 2022, Ms. Bunts signed a contractual agreement with the District to serve as a teacher for the 2022-23 school year. On September 6, 2022, Ms. Bunts submitted her resignation to the District, effective September 23, 2022. In her resignation, Ms. Bunts stated she was reconsidering her future in her current job position following an incident at school. On September 8, 2022, the District informed Ms. Bunts

she was not released from her contract and the possible consequences of breaching her contract. Ms. Bunts did not return to fulfil her contract with the District. The District Board voted to report Ms. Bunts' breach of contract to the SCDE on September 26, 2022. The District reported the matter to the SCDE on October 17, 2022.

After considering the evidence, the State Board finds that the evidence presented demonstrates that Ms. Bunts breached her contract with the District, and that just cause exists to suspend Ms. Bunts' certificate 302766 for a period of one year, commencing on March 14, 2023, and ending on March 13, 2024.

CONCLUSIONS OF LAW

"The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person." Just cause includes, *inter alia*, "unprofessional conduct" and "willful violation of the rules and regulations of the State Board of Education." S.C. Code Ann. § 59-25-160 (3) and (4) (2020). Pursuant to 24 S.C. Code Regs. 43-58 (2) and (14) (2021), the State Board of Education has the legal authority to suspend a certificate for "failure to comply with the provision of a contract without the written consent of the local school board." With respect to breach of contract, "any teacher who fails to comply with the provisions of his [or her] contract without written consent of the school board shall be deemed guilty of unprofessional conduct." S. C. Code Ann. § 59-25-530 (2020). "Upon formal complaint of the school board, substantiated by conclusive evidence, the state board shall suspend or revoke the teacher's certificate, for a period not to exceed one calendar year." *Id.*

The State Board finds that the evidence presented demonstrates that Ms. Bunts breached her contract without the consent and/or approval of the District. Accordingly, the evidence presented supports the State Board's determination that just cause exists to suspend the educator certificate of Kelly Marie Bunts for a period of one year, commencing on March 14, 2023, and ending on March 13, 2024.

If Ms. Bunts wishes to have her educator certificate reinstated at the end of the suspension period, she shall make a written request to the SCDE's Office of Educator

Services and shall meet all certification requirements in effect at the time she requests reinstatement. Ms. Bunts shall also pay the applicable reinstatement fee. The suspension of Kelly Marie Bunts' educator certificate 302766 shall be reported to the NASDTEC Clearinghouse and all South Carolina school districts within thirty days from the date of this order, with the reason stated as "unprofessional conduct, breach of contract, willful neglect of duty, and failure to comply with the provisions of a contract without the written consent of the local school board."

AND IT IS SO ORDERED.
