ORDER OF SUMMARY SUSPENSION

SUMMARY OF THE CASE

The State Board of Education (State Board) considered this matter on April 22, 2024. In accordance with S.C. Code Ann. § 1-23-370(c) (2020), § 59-5-10 (2020), and State Board Rule of Governance BBABA, the South Carolina Department of Education (SCDE) requested that the Chair of the State Board summarily suspend the educator certificate of Shane Michael Stryker, educator certificate 258173, as a result of his arrest on the state felony charge of eavesdropping in Georgia.

The SCDE has reason to believe that, due to the serious nature of these allegations of misconduct, Mr. Stryker may pose a threat to the health, safety, and welfare of students, who may be under his instruction and that emergency action is required. After considering the evidence presented by the SCDE, the Chair of the State Board finds that Mr. Stryker's educator certificate shall be summarily suspended until a due process hearing is held and/or this matter is otherwise resolved. The SCDE is directed to serve notice on Mr. Stryker of the summary suspension, as well as the possible suspension or revocation of his educator certificate.

FINDINGS OF FACT

Mr. Stryker holds a South Carolina educator certificate and has over nineteen years of educator experience. At the time of the incident, Mr. Stryker was a teacher for Dorchester School District Two (District). He was placed on administrative leave from the District on January 25, 2024.

On or about February 3, 2024, Mr. Stryker was arrested for felony eavesdropping in Cobb County, Georgia. According to the arrest warrant, it has been alleged that Mr. Stryker hid a cell phone on the counter of a hotel room bathroom to record video of someone else.

The SCDE has reason to believe that, due to the serious nature of this allegation of misconduct, Mr. Stryker may pose a threat to the health, safety, and welfare of students who may be under her instruction, and that emergency action is required. After considering the evidence presented by the SCDE, the Chair of the State Board finds that Mr. Stryker's educator certificate shall be summarily suspended until a due process hearing is held and/or this matter is otherwise resolved. The SCDE is directed to serve notice on Mr. Stryker of the summary suspension, as well as the possible suspension or revocation of his educator certificate.

CONCLUSIONS OF LAW

"The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person." S.C. Code Ann. § 59-25-150 (2020); S.C. Code Ann. § 59-25-160 (2020). Just cause includes unprofessional conduct, crime against the law of this State, and evident unfitness for position for which employed. S.C. Code Ann. § 59-25-160 (2020); 24 S.C. Code Regs. 43-58 (2021). In accordance with S.C. Code Ann. § 1-23-370(c) (2020), "If the agency finds that the public health, safety or welfare imperatively requires emergency action, and incorporates a finding to that effect in its order, summary suspension of a license may be ordered pending proceedings for revocation or other action." Pursuant to S.C. Code Ann. § 59-5-10 (2020) and State Board Rule of Governance BBABA, the Chair of the State Board finds that as a result of the allegations of Mr. Stryker's unprofessional conduct, crime against the law of this State or the United States, and evident unfitness for the position for which employed, due to his arrest for felony eavesdropping, there is reason to believe Mr. Stryker may pose a threat to the health, safety, and welfare of students and emergency action is required.

Accordingly, the educator certificate of Shane Michael Stryker, certificate number 258173, is summarily suspended until a due process hearing is held and/or this matter is otherwise resolved. The SCDE is directed to serve notice on Mr. Stryker of the summary suspension, as well as the possible suspension or revocation of her educator certificate.
