**CONSENT ORDER OF SUSPENSION
(BREACH OF CONTRACT)**

SUMMARY OF THE CASE

The South Carolina State Board of Education (State Board) considered this matter on March 12, 2024. On March 2, 2023, the South Carolina Department of Education (SCDE) sent Brittney Michelle DeRosa a notice via regular and certified mail of her right to a hearing regarding the possible suspension of her South Carolina educator certificate based on her breach of contract. Ms. DeRosa timely requested a hearing in the matter. Prior to the hearing, Ms. DeRosa contacted the Lexington County School District Two (District) to discuss an alternative resolution. Ms. DeRosa has agreed to waive her right to a hearing and enter this Consent Order of Suspension.

After considering the evidence presented, the State Board voted to suspend Ms. DeRosa's educator certificate for a period of one year, commencing January 1, 2023, and ending December 31, 2023.

FINDINGS OF FACT

This case concerns a formal complaint from the Lexington County School District Two seeking the suspension of the educator certificate of Ms. DeRosa for breach of contract. The State Board has jurisdiction in this matter pursuant to S.C. Code Ann. § 59-25-150 (2020) and S.C. Code Ann. § 59-25-530 (2020).

On May 9, 2022, Ms. DeRosa signed a contractual agreement with the District to serve as a teacher for the 2022-2023 school year. Ms. DeRosa submitted her resignation on December 6, 2022, effective December 19, 2022, citing the medical necessity of a family member. The District informed Ms. DeRosa that she would not be released from her contract via letter on January 11, 2023. She did not return to fulfill her contract. On

January 10, 2023, the School Board of Trustees voted to report Ms. DeRosa's breach of contract to the SCDE. On February 24, 2023, the District reported the matter to the SCDE.

After being notified of the pending action against her educator certificate, Ms. DeRosa contacted the District to discuss an alternate resolution. Ms. DeRosa has agreed to the suspension of her educator certificate for a period of one year, beginning January 1, 2023, and ending December 31, 2023.

After considering the evidence, the State Board finds that the evidence presented demonstrates that Ms. DeRosa breached her contract with the District, and that just cause exists to suspend Ms. DeRosa's certificate 284604 for a period of one year, commencing on January 1, 2023, and ending December 31, 2023.

CONCLUSIONS OF LAW

"The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person." Just cause includes, inter alia, "unprofessional conduct" and "willful violation of the rules and regulations of the State Board of Education." S.C. Code Ann. § 59-25-160 (3) and (4) (2020). Pursuant to 24 S.C. Code Regs. 43-58 (2) and (14) (2021), the State Board of Education has the legal authority to suspend a certificate for "failure to comply with the provision of a contract without the written consent of the local school board." With respect to breach of contract, "any teacher who fails to comply with the provisions of his [or her] contract without written consent of the school board shall be deemed guilty of unprofessional conduct." S. C. Code Ann. § 59-25-530 (2020). "Upon formal complaint of the school board, substantiated by conclusive evidence, the State Board shall suspend or revoke the teacher's certificate, for a period not to exceed one calendar year."

The State Board finds that the evidence presented demonstrates that Ms. DeRosa breached her contract without the consent and/or approval of the District. Accordingly, the evidence presented supports the State Board's determination that just cause exists to suspend the educator certificate of Brittney Michelle DeRosa for a period of one year,

commencing on January 1, 2023, and ending on December 31, 2023. If Ms. DeRosa wishes to have her educator certificate reinstated at the end of the suspension period, she shall make a written request to the SCDE's Office of Educator Services and shall meet all certification requirements in effect at the time she requests reinstatement. Ms. DeRosa shall also pay the applicable reinstatement fee. The suspension of Ms. DeRosa's educator certificate 284604 shall be reported to the NASDTEC Clearinghouse and all South Carolina school districts within thirty days from the date of this order, with the reason stated as "unprofessional conduct, breach of contract, willful neglect of duty, and failure to comply with the provisions of a contract without the written consent of the local school board."

AND IT IS SO ORDERED.
