**CONSENT ORDER OF SUSPENSION
(BREACH OF CONTRACT)**

SUMMARY OF THE CASE

The South Carolina State Board of Education (State Board) considered this matter on November 5, 2024. On September 16, 2024, the South Carolina Department of Education (SCDE) sent Dianna Elaine Painter a notice via regular and certified mail of her right to a hearing regarding the possible suspension of her South Carolina educator certificate based on her breach of contract. Ms. Painter timely requested a hearing in the matter. Prior to the hearing, Ms. Painter contacted the SCDE to discuss an alternate resolution. Ms. Painter has agreed to waive her right to a hearing and enter this Consent Order of Suspension.

After considering the evidence presented, the State Board voted to suspend Ms. Painter's educator certificate for a period of one year, commencing November 5, 2024, and ending November 4, 2025.

FINDINGS OF FACT

This case concerns a formal complaint from the Greenville County School District seeking the suspension of the educator certificate of Ms. Painter for breach of contract. The State Board has jurisdiction in this matter pursuant to S.C. Code Ann. § 59-25-150 (2020) and S.C. Code Ann. § 59-25-530 (2020).

On April 12, 2024, Ms. Painter signed a contractual agreement with Greenville County School District to serve as a teacher for the 2024-2025 school year. Ms. Painter submitted her resignation on August 18, 2024, effective immediately. She did not provide a reason for her resignation. The Greenville County School District informed Ms. Painter that she would not be released from her contract until a satisfactory replacement had

been obtained or the Superintendent determined that no replacement was necessary via letter on August 21, 2024. On August 27, 2024, the School Board of Trustees voted to report Ms. Painter's breach of contract to the SCDE. On September 10, 2024, the District reported the matter to the SCDE.

After being notified of the pending action against her educator certificate, Ms. Painter contacted the SCDE to discuss an alternate resolution. Ms. Painter has agreed to the suspension of her educator certificate for a period of one year, beginning November 5, 2024, and ending November 4, 2025.

After considering the evidence, the State Board finds that the evidence presented demonstrates that Ms. Painter breached her contract with the District, and that just cause exists to suspend Ms. Painter's certificate 258268 for a period of one year, commencing on November 5, 2024, and ending November 4, 2025.

CONCLUSIONS OF LAW

"The South Carolina Board of Education may, for just cause, either revoke or suspend the certificate of any person." Just cause includes, inter alia, "unprofessional conduct" and "willful violation of the rules and regulations of the State Board of Education." S.C. Code Ann. § 59-25-160 (3) and (4) (2020). Pursuant to 24 S.C. Code Regs. 43-58 (2) and (14) (2021), the State Board of Education has the legal authority to suspend a certificate for "failure to comply with the provision of a contract without the written consent of the local school board." With respect to breach of contract, "any teacher who fails to comply with the provisions of his [or her] contract without written consent of the school board shall be deemed guilty of unprofessional conduct." S. C. Code Ann. § 59-25-530 (2020). "Upon formal complaint of the school board, substantiated by conclusive evidence, the State Board shall suspend or revoke the teacher's certificate, for a period not to exceed one calendar year."

The State Board finds that the evidence presented demonstrates that Ms. Painter breached her contract without the consent and/or approval of the Greenville County

School District. Accordingly, the evidence presented supports the State Board's determination that just cause exists to suspend the educator certificate of Dianna Elaine Painter for a period of one year, commencing on November 5, 2024, and ending on November 4, 2025.

If Ms. Painter wishes to have her educator certificate reinstated at the end of the suspension period, she shall make a written request to the SCDE's Office of Educator Services and shall meet all certification requirements in effect at the time she requests reinstatement. Ms. Painter shall also pay any applicable reinstatement fee. The suspension of Ms. Painter's educator certificate 258268 shall be reported to the NASDTEC Clearinghouse and all South Carolina school districts within thirty days from the date of this order, with the reason stated as "unprofessional conduct, breach of contract, willful neglect of duty, and failure to comply with the provisions of a contract without the written consent of the local school board."

AND IT IS SO ORDERED.
